There was one interment of remains in 2016.

Sale of cremation and burial spaces equaled \$1,500. Interest in bank accounts came to \$15; other income included donations of \$100. Total revenue for 2016 was \$1,615.

Grounds maintenance costs were \$125. Bank charges were \$6. We received no invoice for our share of liability insurance with TIRRA in 2015.

Total expenses for 2016 were \$131.

St.Margaret's overall financial situation for 2016 was as follows: the year began with \$32,998 in the bank. Excess of revenues over expenses equaled \$1,484 leaving us with a balance of \$34,482,

Things have continued to remain quiet at the cemetery with regards to development plans for the ditch, pathways and the new green burial area. Regular maintenance continues with our spring clean up and upkeep during the rest of the year. A shoreline-monitoring program has begun under the guidance of The Thetis Island Nature Conservancy and Nikki Wright of Seachange.

Many thanks to the volunteers who come forward to help with the spring clean up and other projects. Continued thanks to Norm Kastings for lawn maintenance.

St.Margaret's Cemetery is managed by a Cemetery Board in compliance with the Provincial Cremation, Interment and Funeral Services Act now under Consumer Protection B.C. It operates as a sub-committee under the auspices of TIRRA and is a registered charity.
