
Thetis Island Community Association:

The Thetis Island Community Association owns Forbes Hall Community Centre, its surrounding grounds, sports court and children's playground. The Hall includes the Health Care Station, the Library, multi-use areas, commercial Kitchen facilities, public access WiFi and EV Charging Station. These facilities are maintained for the enjoyment and use of all islanders and visitors. Forbes Hall is the designated Emergency Shelter for Thetis Island and offers islanders respite from extreme heat, other severe weather conditions and power outages. TICA, which has CRA charitable status, is supported solely through annual membership fees, fundraising, donations and grants, and receives no funding from taxation.

The membership renewal/application form for both associations is on the reverse of this letter. Please return the attached renewal form to facilitate our record-keeping, even when sending an e-transfer. As a CRA Registered Charity, TICA issues tax receipts for all donations over \$25.

Even if you do not use the services provided, the availability of these services provided by the TIRRA and TICA memberships make Thetis Island a better place to live or visit.
